ACCEPTANCE OF NOMINATION RELEASE AND WAIVER FORM**

I hereby accept my nomination for consideration in the TVOntario "Best Lecturer Competition".

These rights are granted without any restriction, reservation or right of rescission or termination of any kind and without any right on my part to enjoin or interfere with TVOntario's exercise of these rights. I hereby waive all moral rights, droit moral or similar rights I may have in and to the Materials and/or the Program. I hereby waive my right to object to any use of the Materials and/or Program as permitted herein, including any such use that constitutes an invasion of privacy or otherwise violates any right which I may have in connection with the Materials and/or Program. I hereby waive my right to bring and prosecute an action for defamation, invasion of privacy, or any similar action.

I represent and warrant that the Materials are original and that I have created the Materials and/or that I own or have licensed any and all rights in the Materials, including the rights granted herein, and have the sole and unfettered right to grant the rights herein granted to TVOntario. I hereby waive any right of inspection or approval of TVOntario's authorized use of the Materials and/or my Likeness. I have not requested, and will not request, either now or in the future, any further remuneration of any kind, beyond the compensation of the opportunity to have the Materials included in the Program for the rights granted to TVOntario in this Release and Waiver.

I agree to indemnify and hold TVOntario, its agents, employees, officers, directors, licensees and assigns harmless from and against all claims, demands, loss, liability, costs, damages and expenses, including legal fees and disbursements, actions for infringement of copyright or otherwise in connection with the exercise of the rights herein granted to it, including any third party claim inconsistent with the statements, representations and warranties I have given herein.
